Investigations

Homicide – (August 17, 2023) - On August 18, 2023, members of CIB followed up on a serious assault which occurred just after 9:00 p.m. in the 900 block of 2nd Avenue East, Owen Sound. Uniformed members had responded to the incident on the 17th and commenced the investigation. On August 24, 2023, the victim, 44-years-of-age of Owen Sound, died from his injuries. The homicide investigation is ongoing.

Homicide – (July 11th, 2023) – Members of CIB continue to investigate the murder of a 17-year-old male at an apartment building in the City of Owen Sound. Dustin NOONAN of Owen Sound was charged with First Degree Murder and remains in custody. Twenty - five-year-old Donte'a Ryan MITCHELL, from North York, was charged with First Degree Murder in August and he remains in custody. In late November, a 17 year old Brampton resident was arrested and charged with First Degree Murder.

Homicide – (July 7th, 2023) – Members of CIB continue to investigate the homicide of a 47-year-old male which occurred at a residence on 2nd Avenue East in the City of Owen Sound. In July, Cody HASSARD was charged with Second Degree Murder as well as other offences and Ashley Lynn DYKSTRA was charged with Accessory After the Fact to Murder as well as other offences, both remain in custody.

Fraud – (June 5th, 2024) – Members of CIB investigated a fraud resulting in an 84-year-old Owen Sound male losing \$43,000 after depositing cash into a bitcoin machine at the direction of telephone scammers convincing him that his identity and bank account were compromised. Investigation thus far has determined that the money was deposited into a bitcoin wallet in Kuwait.

Weapons – (June 24th, 2024) – Members of CIB continued the investigation into a serious assault which has occurred on June 22nd, 2024, in the 300 block of 8th Street East. The investigation revealed that the accused, a 37-year-old Owen Sound man had attacked the victim, a 32-year-old man with a knife. The injuries sustained by the victim included three deep lacerations which required medical care. The accused was arrested on June 25th, 2024 and provided police with an inculpatory statement. The accused has been remanded into custody.

Sudden Death / Fire – (June 30th, 2024) - Just after 1:30pm on Sunday June 30th, 2024, the OSPS received multiple reports of a fire at an apartment in the 1300 block of 3rd Avenue East. Upon arrival, police found a citizen performing lifesaving measures on a 58-year-old man who had left the unit, which had contained the fire and billowing smoke. The man had exited quickly through a window of the third-

floor apartment, gaining access to the roof and tragically slipped and fell. The citizen immediately called 911 and attended to aid his neighbor. The man was transported to the Brightshores Health System Owen Sound, where he succumbed to his injuries.

Investigators from CIB, the Office of the Fire Marshall, and the Office of the Coroner investigated. As a result, it has been determined that the cause of death was from the blunt trauma from the fall from height. At this time, this incident is considered non-suspicious and is not believed to be criminal in nature.

Uniform Assistance

Assault / Robbery *Update* – (May 29th, 2024) – CIB assisted members of uniform patrol with the investigation of an assault and robbery of a 38-year-old Meaford male by three acquaintances in a vehicle and on an east side street before fleeing the area. A concerned citizen contacted police and the victim was located a short distance away, transported to hospital and treated for minor injuries. During the investigation the victim requested the investigation to cease, and a formal Termination of Investigation form was signed by the victim. Two of the suspects have been arrested on unrelated drug, weapons and human trafficking charges by Cornwall Police and the OPP and remain in custody.

Sudden Death – (June 10th, 2024) – CIB assisted members of uniform patrol with the sudden death of a 31-year-old male. The pathology report is pending, but the death is suspected to be the result of a drug overdose.

Distribution of Intimate Images – (June 12^{th} , 2024) – CIB members assisted uniform patrol with the investigation of the distribution of intimate images among Grade 7 & 8 students at local elementary schools. CIB assisted with interviews, and the investigation was concluded by uniform officers who cautioned the involved parties and educated them on the implication of their actions.

Arrest of Wanted Party - (June 28th, 2024) – CIB & uniform members assisted the OPP Repeat Offender Parole Enforcement Team (ROPE) in locating and arresting a 59-year-old Owen Sound male who was in violation of his parole conditions.

Investigations

Homicide – (August 17, 2023) - ***UPDATE***On August 18, 2023, members of CIB followed up on a serious assault which occurred just after 9:00 p.m. in the 900 block of 2nd Avenue East, Owen Sound. Uniformed members had responded to the incident on the 17th and commenced the investigation. On August 24, 2023, the victim, 44-years-of-age of Owen Sound, died from his injuries. The homicide investigation is ongoing, with arrests being made on July 30, 2024.

Homicide – (July 11th, 2023) – Members of CIB continue to investigate the murder of a 17-year-old male at an apartment building in the City of Owen Sound. Dustin NOONAN of Owen Sound was charged with First Degree Murder and remains in custody. Twenty - five-year-old Donte'a Ryan MITCHELL, from North York, was charged with First Degree Murder in August and he remains in custody. In late November, a 17 year old Brampton resident was arrested and charged with First Degree Murder. Court proceedings for the 17 year old are scheduled to begin in fall 2024.

Homicide – (July 7th, 2023) – Members of CIB continue to investigate the homicide of a 47-year-old male which occurred at a residence on 2nd Avenue East in the City of Owen Sound. In July, Cody HASSARD was charged with Second Degree Murder as well as other offences and Ashley Lynn DYKSTRA was charged with Accessory After the Fact to Murder as well as other offences, both remain in custody.

Sexual Assault – (July 23rd, 2024) – Investigation of allegation of sexual assault, originally reported in January 2023, reopened after the victim re-attended OSPS to provide additional information. Youth victim alleging that she was sexually assaulted by her biological father in December 2022. Bruce Grey Child & Family Services notified, however there are no current safety concerns for the victim. The investigation is continuing.

Uniform Assistance

Assault – (July 11, 2024) – CIB assisted members of uniform patrol with an assault investigation involving an 8-year-old child being spanked by her father, which was alleged to be excessive force. Investigation revealed that the act was not criminal in nature and no charges were laid. Bruce Grey Child & Family Services participated in the joint investigation with OSPS.

Assault – (July 16, 2024) – CIB assisted members of uniform patrol with locating suspects involved in the assault of a 28-year-old Owen Sound woman. The investigation revealed that the victim had been assaulted inside a vehicle by two suspects, then had jumped out of the vehicle, while it was moving, to escape the suspects. A 24-year-old Owen Sound woman and a 33-year-old Saugeen Shores male were charged with numerous Criminal Code offences.

Sudden Death – (July 27, 2024) – CIB assisted members of uniform patrol with the sudden death investigation of a 23-year-old male. The investigation revealed that the body of the deceased male had been recovered from the waters of Georgian Bay and the death was not deemed suspicious.

Sudden Death – (July 28, 2024) - CIB assisted members of uniform patrol with the sudden death investigation of a 36-year-old female. The investigation revealed that the death was not suspicious.

Active: There is one (1) outstanding missing person being investigated, however it is not suspicious in nature.

AUGUST

Investigations

Homicides

There have been no changes to the 3 homicide investigations since the July report and all three remain under investigation.

Fraud – (August 1st, 2024) – CIB continues to investigate a fraud that was reported regarding four fraudulent cheques that were deposited into two separate financial institution. Production orders were obtained from the Ontario Court of Justice and they have been submitted to the two financial institutions. The identity of the fraudster is unknown at this time but with the documents sought from the financial institutions, it should assist police with identifying them.

Fraud – (July to August, 2024) – In July 2024, CIB was contacted by the Major Fraud Unit of the York Regional Police. YRP was investigating a fraud that involved a large sum of money being deposited into the bank account of an Owen Sound resident by fraudulent means. On August 21st, 2024, member of the YRP attended Owen Sound and completed a search warrant at a residence in Owen Sound. As a result of

the investigation, a 77-year-old Owen Sound man has been arrested and charged with Fraud over \$5000 and Possession of Proceeds of Crime.

Aggravated Assault/Weapons/Drug Offences – (August 18th, 2024) - Uniformed officers responded to an east side apartment building for the report of a male with a handgun standing over an unconscious male. Officers arrested a 46 year old Owen Sound man for numerous firearms related offences at the scene. Further investigation revealed that a 27 year old male had been the victim of an assault and was transported to hospital via ambulance. It was later learned that the victim suffered a significant head injury and was transported to a London hospital for further medical treatment. CIB attended, continued the investigation and determined that the victim had been robbed by two suspects, who fled in a motor vehicle. Uniformed officers located and seized the motor vehicle. A subsequent search warrant was obtained and executed on it, with officers locating a quantity of suspected methamphetamine and fentanyl, as well as multiple prohibited weapons. Detectives positively identified the two suspects, who were arrested separately on August 22nd and August 30th. A 22 year old Owen Sound male was charged with numerous criminal offences including Aggravated Assault, Robbery, Possession of Prohibited Weapon and drug offences. A 31 year old Bruce County male was charged with Robbery and Possession of Property Obtained by Crime. The victim remains in hospital in critical but stable condition.

Domestic (Historical) – (August, 2024) - CIB was requested to continue a domestic violence investigation initially reported in August 2023. The victim wished to disclose further incidents of domestic abuse that were not previously reported to police. The victim provided a statement to a detective regarding the historical allegations, and as a result a 59-year-old male was arrested and charged with 14 criminal offences including firearms offences, multiple assaults and other domestic violence related offences.

Missing Person – (August 28th, 2024) – CIB continued the investigation into the disappearance of a 36-year-old Meaford man, who was last seen in Owen Sound, in approximately June, 2024. The investigation has revealed that the missing male is now residing in the Ottawa Ontario area and is no longer considered to be missing.

JUNE

In June 2024, the Auxiliary Unit was busy with community events and assisting the Uniform Branch with ride along hours. The volunteer hours accumulated by the Auxiliary Unit totalled **263**!

On June 13th, members of the Auxiliary Unit participated in the Law Enforcement Torch Run. The LETR is the largest public awareness vehicle and grass-roots fundraiser for Special Olympics. Known honourably as Guardians of the Flame, law enforcement members and Special Olympics athletes carry the "Flame of Hope" into the Opening Ceremony of local competitions, and into Special Olympics Provincial, National, Regional and World Games.





All Ontario and Superior Courts of Justice for the Owen Sound Courthouse remain as hybrid courts. The majority of custody court appearances still remain virtually from the correctional facility however all new bail arrests by the police services (OPP and Owen Sound Police) are appearing in-person at the courthouse. This results in additional Special Constable hours required to cover those court appearances.

Criminal Court trials are being scheduled into 2025 and as a result trial dates are being scheduled during summer months when officers would normally be taking annual leave. Trials are being set with the consideration of defence counsel availability however officer annual leave has not yet been drawn for 2025 leaving a number of dates that will no longer be available for officers for annual leave selection. This will have a negative impact on member time off and wellness.

Bylaw – June-July-August 2024:

Bylaw Clerk advising that correspondence was prepared to all taxi brokers advising of new fees, new tariff cards and that all meters needed to be changed by August 29, 2024 in accordance with new bylaw. All taxi companies complied with meter changes to new rates and all companies received their refund/reimbursement cheques.

Financial/Risk Implication(s):

Providing court security and transporting persons in custody comes with inherent risk, while the efficient and accurate processing of judicial documentation is foundational to community safety. The Owen Sound Courthouse serves all of Grey County, however court security is the responsibility of the Owen Sound Police Service. In July 2024 Grey County council voted on the sharing of court security costs between the municipalities and the City of Owen Sound commencing in 2025.

OPERATIONS PLAN:

The administrative services within Records, Courts, and Bylaw are essential components of the OSPS Mission to deliver high quality policing services that strengthen public safety and community wellbeing. Community Safety and Sustainability are two of the four strategic priorities of the Owen Sound Police Services Board. As part of the Operational Plan, Court security costs will be assessed and reviewed annually to advocate for a sustainable police funding model.


A new class of Communicators started July 16th and is doing very well.



In June, July, and August 2024, the average daily number of incoming emergency 911 calls to the OSECC surpassed 200, with a steady increase each month since March. With 7110 emergency calls incoming from the 911 phone line in August, this was an average of 229 calls/day during August, compared to 220/day in July, and 205/day in June (Figure 1). Year-to-date, the total volume of incoming 911 calls are down by 17%, partly due to the high volume of non-answerable 911 calls that peaked in June and July 2023. For example, June 2023 recorded 1285 No Answer calls, compared to June 2024's 536.




The OSECC operates as both a primary and secondary PSAP. Approximately 70% of 911 calls are transferred to another PSAP, while Communicators in the OESCC dispatch about 30% of 911 calls to OSPS, five other police agencies, more than 50 fire stations, and Grey County Transportation. In August 2024, there was a daily average of 63 calls from the 911 emergency line dispatched by the OSECC, representing the highest daily average per month so far in 2024 (Figure 2). Year-to-date, however, the overall volume of 911 calls transferred and dispatched are down from this same time last year.





Calls that are dispatched through CAD come from a variety of sources such as the non-emergency phone line, walk-ins, officer generated, as well as the 911 phone line. July and August 2024 experienced record high volumes of dispatched calls. In July there were 6659 calls dispatched; in August there were 6640 – representing a daily dispatch rate per month of 215 calls in July and 214 calls in August (as shown in Figure 3). Year-to-date increases are attributable to both police and fire agencies dispatched by OSECC.



The daily dispatch rate for OSPS also reached record highs in July and August (Figure 4), with monthly dispatch call volumes surpassing 1900, and the average daily rate per month surpassed 60 per day. So far year-to-date however, balanced by the winter months, the overall volume of dispatched calls for OSPS is down 4%.



Information Technology (IT) Infrastructure – June-July-August 2024:

Over the summer months, the IT team was engaged in the final design and procurement of new communications centre equipment for the OSECC renovation, including networking, infrastructure and console configurations. This also included necessary maintenance to the building-wide Uninterruptible Power Supply (UPS) and generator systems.

Computer Aided Dispatch is slated for refresh in November with IT staff coordinating hardware and software procurements and installations leading up to this rollout involving 14 desks plus supporting servers.

Ongoing work on NG911 continues, with documentation and numerous meetings for coordination of services/installs with vendors (Bell, Netagen, Komutel) and hosted clients. Bell Canada delays in network infrastructure deployment is a challenge, however, OSPS is scheduled to complete its backup and main site certifications before the end of the year.

In addition, IT has finalized a security audit for the Saugeen Shores Police Service and are now working on West Grey Police Service's audit.

Financial/Risk Implication(s):

Risk management and contingency planning are integral to the day-to-day operations of a Public Safety Answering Point (PSAP). While the OSECC continues to grow and evolve, OSPS strives to maintain a balance of staffing that best aligns with workload demands, member wellness, emergency response standards, and contracted client expectations.

OPERATIONS PLAN:

Within the 2023-2026 OSPS Operations Plan, six unique actions have been identified as important to reach towards the goal of fostering a sustainable emergency communication centre. In addition, monitoring and publishing emergency response times to priority calls is part of the goal to address safety concerns identified by the community.

Police-reported Crime in Canada, 2023

Statistics Canada released the 2023 police-reported crime statistics on July 25, 2024, with key trends across Canada presented in the attached Infographic. This annual publication draws from the Uniform Crime Reporting (UCR) Survey, a census of all crime known to police services. The UCR statistics reflect police response to criminal incidents and laying of appropriate charges after investigating, and conforms to a nationally approved set of common crime categories and definitions.

The Crime Severity Index (CSI) measures changes in crime by tracking both the volume and the seriousness of the crimes committed. Police-reported crime in Canada, as measured by the Total CSI, increased for the third consecutive year, up by 2% in 2023, continuing an upward trend that began in 2015. According to *The Daily* (July 25, 2024), relatively large shifts in certain types of crime led to an increase in the Non-violent CSI (such as increased reporting of child pornography, fraud, shoplifting, motor vehicle theft), while the Violent CSI remained virtually unchanged.

Police-reported crime statistics can be influenced by different police priorities and targeted police enforcement, as well as the community's level of trust and confidence reporting crimes to police. It is important to note that Criminal Code violations generally account for less than a third of all police calls for service, which may be influenced by other community-wide safety and wellbeing issues such as homelessness, mental health, and addictions.

Police-reported Crime in Owen Sound, 2023

For context, most figures attached to this report include information for Owen Sound Police Service, alongside 27 other Ontario municipal police agencies serving under 120,000 people (ordered by highest to lowest population) and the 2023 average of these 28 police services. Ontario and Canada are also included in the graphs when applicable.

Total CSI includes both Violent and Non-Violent offences. Similar to the national trends, Owen Sound's Total CSI increased in 2023. Based on crime-reported to OSPS, the Total CSI rose by 18%, to 123 in 2023 from 105 in 2022. As shown in **Figure 1**, compared to the 28 municipal police services in Ontario serving <120,000 people, Owen Sound recorded the second highest Total CSI (behind Timmins) in 2023. Similar percentage increases in Total CSI were also seen in Kawartha Lakes and Smiths Falls.

Unlike the national Violent CSI which remained relatively unchanged, the Violent CSI in Owen Sound rose by 67% to 200 in 2023 from 120 in 2022 (**Figure 2**). Of the 28 police services included, Owen Sound was the highest Violent CSI in 2023 influenced significantly by 4 violations causing death in 2023.

The Non-violent CSI includes both Property Crimes and Other Criminal Code (CC) offences. While the national Non-violent CSI rose by 3%, the Non-violent CSI in Owen Sound declined by 6%, to 94 in 2023 from 99 in 2022 (**Figure 3**). Of the 28 municipal police services serving under 120,000 people in Ontario, Owen Sound's Total, Violent, and Non-violent CIS are well above their collective 2023 average.

Owen Sound's historical CSIs back to 2013 are shown in **Figure 4**. Similar to the national trends, the Total CSI was on an upward trend prior to the pandemic, with consecutive increases from 2014 to a high of 110 in 2020. Since a drop in 2021, the Total CSI is again increasing and reached a new peak of 123 in 2023. Owen Sound's Violent CSI surpassed and has remained above the Total CSI and Non-Violent CSI since 2017, with a notable increase in 2023. The Non-violent CSI in Owen Sound has remained below the Total CSI since 2017 and has followed similar fluctuations as the Total CSI since 2017 with the exception of a decline in 2023.

Clearance rates represent the portion of criminal incidents cleared by charge or cleared otherwise by police. Like the CSI, the Total Weighted Clearance Rate takes into account both Violent and Non-violent offences and weights by severity. As shown in **Figure 5**, in 2023 Owen Sound's Total Weighted Clearance rose to 58% from 47% in 2022. OSPS' clearance rate is above the average of the 28 police services included in the graph and significantly higher than Ontario and Canada.

Figure 6 highlight's OSPS' historical Total, Violent, and Non-Violent weighted clearance rates back to 2013. As shown in the graph, the Total Weighted Clearance Rate of 58% is at the highest rate ever over the past 10 years. All three weighted clearance rates rose in 2023, after experiencing declines the previous year.

In terms of actual counts of crime, based on the most serious violation within the incident, there were 2,566 Criminal Code violations (excluding traffic) reported to OSPS in 2023. This was a 5.6% increase in volume from 2022 (**Figure 7**) and a 10-year peak. Total increases were driven mainly by a 15% increase in Violent Crime and a 5% increase in Property Crime, while Other Criminal Code offences remained relatively stable in volume.

Actual incidents of Violent Crime reported to OSPS in 2023 are captured in **Figure 8**. In 2023 there was a total of 619 reported violent crimes or crimes against persons in Owen Sound, compared to 540 in 2022.

Most numerous violent offence types:

- Level one assaults (186),
- Uttering threats (125), and
- o Criminal Harassment (89).

Notable violent offence increases reported in:

- Violations causing death (4 in 2023, compared to 0 in 2022),
- Sexual assault with weapon, level two (3 in 2023 compared to 0 in 2022),
- Sexual assault, level one (58 in 2023 compared to 45 in 2022, +29%),
- Sexual violations against children (20 in 2023 compared to 14 in 2022, +43%),
- Assault, aggravated, level three (6 in 2023 compared to 2 in 2022, +200%),

- o Firearms, use of, discharge, pointing (4 in 2023 compared to 0 in 2022),
- o Forceable confinement or kidnapping (6 in 2023 compared to 2 in 2022, +200%), and
- o Indecent/harassing communications (40 in 2023 compared to 16 in 2022, +138%).

Notable violent offence decreases reported in:

- o Robbery (4 in 2023, down 56% from 9 in 2022), and
- o Non-consensual distribution of intimate image (0 in 2023, down from 5 in 2022)

Actual incidents of Non-violent crimes reported to OSPS in 2023 are shown in **Figure 9**. In 2023 there were 1236 property crimes and 711 other Criminal Code offences.

Most numerous non-violent offence types:

- o Total Thefts under \$5000 (708),
- Total Administration of justice violations (531), including fail to comply with order (255), fail to appear (138), and breach of probation (136).
- Fraud (230), and
- Mischief (186).

Notable non-violent offence increases reported in:

- Shoplifting \$5000 or under (233 in 2023, up 73.9% from 134 in 2022)
- o Disturb the peace (116 in 2023, up 28.9% from 90 in 2022).
- Arson (5 in 2023, up 150% from 2 in 2022).

Notable non-violent decreases reported in:

- Total Administration of Justice violations (531 in 2023, down 6.7% from 569 in 2022).
- o Breaking and entering (59 in 2023, down 14.5% from 69 in 2022)
- o Theft of motor vehicle (22 in 2023, down 31.3% from 32 in 2022)
- o Total theft over \$5000 (9 in 2023, down 50% from 18 in 2022).

The Total Crime Rate is another way of looking comparatively at crime. A crime rate is measured by the actual count of crime divided by population per 100,000. This measure considers only the volume of crime. **Figure 10** includes the Total Crime Rate for the 28 municipal police services in Ontario serving under 120,000 people. In 2023, Owen Sound recorded the highest Total Crime Rate of these other police services, well above their average as well as the provincial and national rates.

Dividing the actual count of criminal code violations (excluding traffic) by the total authorized sworn officers in a police service is an indicator of the volume of criminal workload per officer. As shown in **Figure 11**, on average, police officers at OSPS handled 63 criminal offences each during 2023, compared to 25 in Ontario or 31 in Canada. This 2023 OSPS workload indicator is up from 59 in 2022, and 49 in 2021, and the highest in 2023 of the other 27 police services in Ontario serving under 120,000 people. It is also important to emphasize that this does not include the many non-criminal matters that place demands on police such as mental health calls, check wellbeing, disputes, missing persons, or sudden deaths, and does not include any community policing or proactive activities.

OSPS continue to work with community partners and are committed to community policing efforts that will address long term solutions to issues influencing the safety and wellbeing of Owen Sound.

FINANCIAL/RISK IMPLICATION(S):

There may be financial and risk implications as a result of increased volume, severity, and complexity of crime in terms of the demands on police resources required to investigate and lay charges.

OPERATIONS PLAN:

Measuring and monitoring police-reported crime in Owen Sound helps to better understand the community safety challenges in the community. Addressing safety concerns identified by the community, and addressing controlled substances, firearms, and violent crimes are two goals within the strategic priority of Community Safety.

County to Share Court Security and Prisoner Transportation Costs with the City Beginning in 2025

July 29, 2024

General City News

Grey County will begin sharing court security and prisoner transportation costs at the Ontario Court of Justice and Superior Court of Justice with the City of Owen Sound in 2025. Currently in Ontario, these court expenses are the sole responsibility of the local municipality.

In 2024, Owen Sound anticipates a \$229,440 court security and prisoner transportation program shortfall. Because the courts in Owen Sound serve the entire region and because these costs are rising and putting an unfair burden on the City of Owen Sound ratepayers, Grey County Council voted to create a cost-sharing agreement with the City.

As part of the **2023 Service Review**, Council had approved 49 initiatives under six broad themes. Service Review action 3B5, under the theme of negotiating cost-sharing opportunities, was to "Build a business case that can be shared with the Province to review critical funding needs for Court Security."

The City of Owen Sound and the Owen Sound Police Service have worked to find service efficiencies. They have taken the initiative to lead numerous delegations and submit correspondence to the Province requesting that costs associated with court security and prisoner transportation be fully transferred to the Province or that the Province reevaluate the provincial transfer payment program to better accommodate the financial needs of municipal police services that fulfill these mandated services. Grey County and the City will continue to collaborate on future advocacy to the province to change this funding system, which is unique to Ontario.


- The Community Safety and Policing Act states that police services are responsible for the security of courthouses within their jurisdiction.
- The Owen Sound courthouse is a consolidated courthouse housing both the Ontario Court of Justice and the Superior Court of Justice, which provides Court Services for a wider region.
- In 2023, the Owen Sound taxpayer was responsible for the \$236,233 shortfall between costs related to court security and prisoner transportation and the provincial transfer amounts.
- In 2023 the Provincial transfer covered 60% of the City costs.

POLICE-REPORTED

IN CANADA, 2023

The volume and severity of crime, as measured by the Crime Severity Index (CSI),1 increased for the third consecutive year, up 2% in 2023.

Relatively large shifts in certain types of crime led to an increase in the Non-violent CSI, while the Violent CSI remained virtually unchanged. Annual changes in the crime rate, or the volume of crime, have been similar to the CSI over time.



Important shifts in certain violent and non-violent crimes impacted the CSI across Canada

In 2023, there were 778 victims of homicide, 104 fewer than in 2022.

Gang-related homicides continued to account for about one-quarter (22%) of all homicides; 78% of these were committed with a firearm, most often a handgun.





The proportion of women who were killed by their spouse or intimate partner was approximately **5 times higher** than the proportion of men (31% versus 6%).3

HATE CRIME INCIDENTS

The number of police-reported hate crimes rose 32%. Hate crimes targeting a religion or a sexual orientation accounted for most of the increase.

In 2023, the change in the CSI varied across the provinces and territories compared with 2022

To determine severity, all crimes are assigned a weight based on sentences handed down by Canadian courts. More serious crimes are assigned higher weights, while less serious crimes are assigned lower weights. As a result, more serious offences have a greater impact on changes in the index. The CSI is an area-based measure that summarizes police-reported crime as an index value. The CSI is not an indicator of overall safety and should be interpreted in a broader community context. Statistics Canada's Canadian Centre for Justice and Community Safety Statistics will be releasing their annual police-reported crime statistics for 2023 on July 25, 2024. National and provincial trends, and statistics for municipal police services will be highlighted in their Daily news and data tables will be available publicly.

2023 Crime Severity Index – Owen Sound

Statistics Canada's Crime Severity Index (CSI) takes into account both the volume and the seriousness of crime. The index is calculated with weight assigned to each offence that are derived from average sentences handed down by criminal courts. The more serious the average sentence, the higher the weight for that offence. As a result, more serious offences have greater impact on changes in the index. All criminal code offences are included in this index. The clearance rate refers to the number of criminal incidents solved by police. The weighted clearance rate is based on the same principles as the CSI whereby more serious offences are assigned a higher "weight" than less serious offences.

Total Crime Severity Index

- Total Crime Severity Index (CSI) is 123.4 in 2023, an increase of +18.1% from the 2022 index of 104.5.
- Total Weighted Clearance Rate rose in 2023 to 58% from 47% in 2022.





To Our Police Partners and Police Services Boards Stakeholders

July 10, 2024

The Board of Directors of Crime Stoppers of Grey Bruce finds it necessary to reach out to our Police Services, and Police Services Boards in Grey and Bruce counties to advise of our program's current situation.

Despite our best efforts, for the last few years our program has been struggling to attract new and active Board members. This, along with ongoing challenges in fundraising due to the local demand for charitable dollars has left our program in desperate need of funds to continue.

Aside from one full-time Civilian Program Coordinator, our program is entirely operated by volunteers.

Since its inception in 1987, Crime Stoppers of Grey Bruce has served the citizens of our two counties by providing an anonymous service to receive tips about unsolved crimes which are securely passed along to law enforcement. Rewards are paid out for successful tips. Our statistics to date show the value of the information provided by the citizens of Grey and Bruce through our program:

Without a new source of funding sufficient to take us through the 2025 – 2026 fiscal year, Crime Stoppers of Grey Bruce will be unable to continue to operate after our current fiscal year ends on March 31, 2025, at which point we will be required to close our program. We are asking our Police Partners and Police Services Boards stakeholders for an ongoing commitment of financial support.

We would welcome the opportunity to meet with our partners to discuss what is required to keep the program viable.

Crime Stoppers of Grey Bruce will be holding its AGM on September 9, 2024, and at that time if there is not a suitable secure funding plan going forward, the membership will be voting on the fate of our program.
