Resolution of Owen Sound City Council – Community Safety and Well-Being Plan

Owen Sound City Council, at its meeting held on June 10, 2019 considered the above noted matter and adopted Resolution No. R-190610-016 as follows:

WHEREAS under the *Police Services Act, 2019* Councils of municipalities are mandated to develop and adopt a Community Safety and Well-Being Plan by January 1, 2021 working in partnership with a multi-sectoral advisory committee comprised of representation from the police service board and other local service providers in emergency services, health, mental health, education, community and social services, seniors services and children and youth services; and

WHEREAS additional requirements are also outlined in legislation pertaining to conducting consultations, contents of the plan, and monitoring, evaluating, reporting and publishing the plan; and

WHEREAS this approach allows municipalities to take a leadership role in defining and addressing priority risks in their community through proactive, integrated strategies that ensure vulnerable populations receive the help they need from the providers best suited to support them; and

WHEREAS the Grey Bruce Health Unit has established a Healthy Communities Partnership of some of the same agencies that would be involved in developing a Community Safety and Well-Being Plan; and

WHEREAS given that the agencies required to meet with municipalities in Grey County are the same

individuals and meeting with each municipality to develop a plan would be arduous and repetitious;

NOW THEREFORE BE IT RESOLVED THAT:

- 1. The City of Owen Sound requests that the Council of the County of Grey take a leadership role to initiate discussions with its member municipalities in determining if municipalities wish to develop a joint Community Safety and Well-Being Plan of willing partners suitable for the County of Grey or portions thereof; and
- 2. A copy of this resolution be circulated to Grey County member municipalities, Police Service Boards in the County of Grey, and the Grey Bruce Health Unit Healthy Communities Partnership seeking their support in development of a joint Community Safety and Well-Being Plan.

During May members of CIB conducted investigations regarding sexual assault, fraud, break and enter, animal cruelty, weapons offences and arson.

On May 01, 2019 a residential break and enter occurred where one of the family dogs was violently assaulted with a weapon. The dog did not survive the attack. A 23 year old man from Owen Sound was identified and charged by the Criminal Investigations Branch with several offences including break and enter, animal cruelty and possession of a weapon. The incident has been well documented in the local media and several charity events have been held to benefit the victim's family.

An investigation into a 'sleight of hand' fraud was concluded on May 02, 2019 with several charges against a 38 year old male from Durham Region. The man was identified as having conducted similar frauds in Kingston, Cobourg, Toronto, Hamilton and Halton Region. Charges of theft, identity theft, fraud, identity fraud and possession of property obtained by crime were laid regarding the Owen Sound incident.

On May 12, 2019 the Criminal Investigations Branch assisted uniform members with a call that escalated into a barricaded person at a downtown apartment. The accused then confined his daughter in the apartment and began throwing projectiles and smoke bombs at responding police officers. One of the projectiles started a fire in the apartment that was extinguished by police. A lengthy stand-off took place until the accused, a 34 year old man, eventually surrendered to an Owen Sound Police officer who had been negotiating with him. The accused is charged with numerous offenses including arson, using explosives against a person, weapons offences, threatening and mischief to property. No one was injured in the incident.

On May 23, a detective delivered a presentation at Owen Sound City Hall regarding Drug Awareness and Hypodermic Needle safety.



Report to the Board: Drug Enforcement

The Drugs and Intelligence Unit continues to investigate persons involved in the trafficking of various drugs in Owen Sound and Grey-Bruce. As in previous months, the focus continues to be on Fentanyl and Crystal Methamphetamine.

In May, the Drug Enforcement Unit began a joint forces methamphetamine trafficking investigation with the Grey-Bruce O.P.P. and the Perth County O.P.P. The investigations involved the distribution of crystal methamphetamine to several areas of Grey-Bruce Counties including the City of Owen Sound.

On May 02, 2019 the Drug Unit participated in a joint force investigation with Saugeen Shores Police, Hanover Police and the Grey-Bruce O.P.P. with the execution of a Controlled Drugs and Substances Act search warrant at a Hanover residence. A Saugeen Shores man and a Hanover woman were arrested and charged with numerous criminal offences including possession of Crystal Methamphetamine for the purpose of trafficking.

The unit executed seven arrest warrants on persons in Owen Sound during the month of May.

The Drug Unit worked with Saugeen Shores Police regarding a firearms investigation. A search warrant was executed at a residence in Port Elgin and a stolen rifle with an obliterated serial number and ammunition were seized.







Number of Events by Day of Week/Hour of Day - May 2019













Crime Stoppers

Crime Stoppers of Grey-Bruce has been in operation since May of 1987. Grey Bruce Crime Stoppers statistics indicate tips provided to police for investigation have resulted in the clearance of over 2600 cases and more than 1600 arrests in Grey and Bruce counties. Crime Stoppers is a successful program worldwide in 32 countries.

Members of the public are encouraged through the offer of a reward and the guarantee of anonymity to provide information that may assist law enforcement agencies to solve crime. Information provided to Crime Stoppers is not traceable back to the person who provided it. Once received, it is passed on to the proper authorities. If the information leads to a positive outcome, the person who provided the information will be eligible for a cash reward, which is paid anonymously. The amount of the award depends upon the significance of the information and severity of the crime. Put simply it is a "three-part" approach to solving the crime problem. Crime Stoppers relies on cooperation between the public, the police, and the private sector to provide a flow of information about crime and criminals.

Police have realized that fear and apathy often prevent the public from getting involved. Crime Stoppers is a system by which the public can anonymously provide details of the events. This system focused on stimulating community involvement and participation. Tipsters can also provide information electronically through a secure web tip.

Crime Stoppers is a Community Project supported by donations of money, goods or services. Contributions from individuals, corporations, clubs, professional associations, retailers, civic and social groups keep the Crime Stoppers program functional.

The success of a Crime Stoppers program cannot be purely judged on statistics; there are many other benefits:

- A greater awareness in the community that there is a crime problem.
- A willingness by the community to fight back against crime if it is given the opportunity and motivation.
- · Improved relationships between police, media, and the community.

The Owen Sound Police Service has seen the benefit of the Crime Stoppers program in our community through numerous arrests and information that led to the recovery of stolen property and the seizure of illicit drugs. In 2018, OSPS received 237 tips. The majority of the tips received by the Owen Sound Police Service are in relation to drugs. These tips often serve as a starting point for investigations. With the current opiate crises and the increase in methamphetamine use and trafficking, having a program to receive and forward information to the police from the public is very important.

Crime Stoppers of Grey Bruce is a close community partner of the Owen Sound Police Service. In the past, the police service has provided office space for the operation of the program and also answered their tip line in our communications centre.
